



LIMITED WARRANTY

1. TIRES COVERED BY THIS WARRANTY.

This Warranty applies to ROADPRO brand truck tires bearing a complete description as required by DOT. This warranty applies to tires manufactured on or after November 1st, 2009. Tires manufactured prior to that date are subject to the preceding warranty policy. Conditions and coverage are subject to change at any time without notice.

2. WHAT IS WARRANTED AND FOR HOW LONG.

a. Material and Workmanship Warranty (50% FREE REPLACEMENT WARRANTY)

Every ROADPRO truck tire is warranted against defects in material and workmanship for the life of the original usable tread up to 2/32" of the remaining tread depth or 5 years from the date of manufacture, whichever comes first. If a tire becomes unserviceable within the first 50% of the original usable tread (calculated by subtracting the difference between the original new tire tread depth and 2/32nd from the original new tire tread depth), it will be replaced with an ROADPRO comparable tire free of charge. 50% free replacement applies to new first quality tires only. Blems, retreads and road hazard tires are excluded from expressed warranty.

Thereafter, the amount of credit allowed is prorated on the basis of tread wear, and is computed by multiplying the ROADPRO dealer's current selling price for an equivalent new ROADPRO tire by the percentage of remaining tread depth. Adjustment credit will be given for each 1/32" of remaining original usable tread depth. The costs for mounting, balancing, applicable taxes, etc., are payable by the user.

Out-of-balance or out-of-round adjustments will be accepted only during the first 2/32" of the original usable tread and depth, and said tire will be replaced with an ROADPRO comparable tire free of charge.

b. Casing Allowance Policy for Steel Radial Truck Tires. After the original tread of a steel radial truck tire, in the sizes listed below, covered by the standard warranty, has been worn off (up to 2/32" of the remaining tread depth) and the standard warranty ends, if the tire is removed for its first and second retreading, and cannot be retreaded, or if the casing of the tire fails during the first or second retread life (up to 2/32" of the remaining tread depth) due to an adjustable condition, the casing allowance will be credited per the following schedule:

3. WHAT IS NOT COVERED (EXCLUSIONS).

- Unserviceability due to road hazards (cut, snags, punctures, bruises, impact breaks, etc.) improper inflation, irregular wear, wheel imbalance, defective mechanical vehicle components (ex: brakes, shocks, rims, etc.), accident, tire, chemicals, chain damage, racing, misuse, overloading, run flat, improper installation, vandalism or gross abuse.
- Damage due to improper regrooving on regroovable tires and the regrooving of non-regroovable tires (without "Regroovable" indication on the sidewall.)
- Damage due to use of an improper inner tube. Radial tires require use of a radial tube. Use of a non-radial tube in a radial tire will result in sudden tire failure.

- Highway tires on vehicles that are normally operated in off highway service.
- No portion of the warranty shall apply to any tires branded "NA" or "NO ADJ".
- Any tire failure that is related to any previous damage(s) and/or repair(s).
- Tire on any vehicles registered and normally used outside the 50 United States, District of Columbia and Canada
- Tires that have been modified with the introduction of liquid sealants or balancers.
- Ozone cracking or weather checking on the tire presented for adjustment more than 4 years after manufacturing date, based on the tires DOT number.
- Loss of time, inconvenience, loss of use of the vehicle or consequential damage.

Exclusions for casing allowance policy:

- Casing which cannot be retreaded due to excessive tread wear.
- Failures resulting from faulty or improper retreading processing.
- Casing during process of third retread or casing retreaded more than twice.
- Tires which have the original DOT serial number or retreader's DOT number removed or rendered illegible.
- Casing presented for adjustment more than 5 years after manufacturing date, based on the tires DOT number.
- Costs of retreading services or materials.

4. OWNER'S OBLIGATION.

- Any tire to be adjusted must be presented to an authorized ROADPRO dealer.
- You must complete and sign the claim form provided by the ROADPRO dealer.
- You must pay costs for mounting, balancing and any other service charges, including applicable taxes.

5. LEGAL RIGHTS.

Any implied warranties, including warranties of Merchantability and Fitness for a particular purpose, shall be limited in duration to the above period. To the extent permitted by law, ROADPRO shall not be responsible for incidental or consequential damages, such as loss of use of the tire or of the vehicle on which it is used, inconvenience or commercial loss. Some states do not allow limitation on how long an implied warranty lasts, or the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights, which vary from state to state. This is the only express warranty applicable to ROADPRO brand tires, and supersedes the terms of any previous warranty. ROADPRO neither assumes nor authorizes anyone to assume for it any other warranty.
